## LEGISLATIVE

How can we accomplish our goals? First, keep up with what is happening across our nation. Excellent sources for information include the VFW Legislative & Security Priority Goals pamphlet, *Checkpoint*

*Newsletter*, the VFW Washington Weekly online, the VFW Action Corps, the VFW Foundation, the National Legislative Service Office in Washington, D.C., the VFW and Ladies Auxiliary National Magazines and Web sites.

Each time one reads or hears of a veteran benefit/entitlement or legislation being discussed, take action. Especially, if the legislation harms our veterans by cutting their benefits and entitlements that they have earned by protecting our nation, our national defense, and our national security. Get your pens in gear and your telephone lines burning. Send e-mails, faxes, letters and/or make personal visits. Communicate with legislators and elected officials. Be polite and courteous as well as brief and to the point using the guidelines taken by the VFW. Thank them and inform them that you will be in contact with them in the future. We must keep in mind that all action taken on legislation concerning veterans **MUST** originate with the VFW. Remember: Numbers are what counts in getting our elected officials to vote or listen to our cause: our veterans. If you disagree with the VFW stance on a particular issue, **DO NOT** indicate you are writing on behalf of the Ladies Auxiliary or the VFW.

Secondly, hold Schools of Instruction at all levels of our organization and in our communities. Educate our sisters, families, friends, and communities on the legislative process. Unfortunately, some schools do not teach government anymore. Most people do not know there are three branches: executive, judicial and legislative. Each branch has special powers and duties according to our Constitution that our forefathers founded for our nation to be preserved and to flourish. As Legislative/VFW-PAC Chairman, be informed and get our Auxiliary Sisters actively involved in legislative issues and VFW-PAC as a unit in conjunction with the VFW. Work the Legislative/VFW-PAC program with your VFW counterpart as a team.

Thirdly, join the VFW Action Corps. By doing so, one will receive information of value that will also be valuable to our veterans once we have taken action. In order for us to be effective, we must help support this area also. We must promote legislation for our veterans' benefits/entitlements and national security. Be prepared to respond immediately to any national Legislative Action Alert posted on either [www.vfw.org](http://www.vfw.org), [www.ladiesauxvfw.org](http://www.ladiesauxvfw.org) or listed in the Washington Weekly requested by our VFW Commander-in-Chief.

Lastly, keep abreast on the latest health issues and the legislation facing our veterans. Traumatic Brain Injury, Post-Traumatic Stress Disorder (PTSD), mental health care, substance-use disorders, the Persian Gulf Syndrome, Hepatitis C, Agent Orange, to mention a few, are all real in the lives of our veterans. Our country promised our veterans health care as a benefit and entitlement. Nevertheless, this is an area most neglected and where our country decreases or eliminates funds first for other programs. Our veterans went to serve our country healthy. Some did not return and others face many trips to medical facilities. Get our active-duty military and veterans to register for the VA before they need medical care. Many of our younger soldiers do not realize the importance of registering now for future services if a need should arise.

### **VFW POLITICAL ACTION COMMITTEE (PAC)**

*It's Time for America's Military Heroes* to receive full compensation for their duty, courage and sacrifices. Our military men and women continually defend our freedom and national security we are so fortunate to have today. It is of utmost importance we ensure veterans are receiving their entitlements as promised for their service to our country. Supporting the VFW Political Action Committee (PAC) is an excellent way to get this done.

VFW National Convention delegates created VFW-PAC 30 years ago. It operates under bylaws approved by the VFW National Council of Administration. Every Ladies Auxiliary should participate in VFW-PAC, because the Board looks out for our national security, our veterans, our military personnel and their families. VFW-PAC supports pro-veteran and pro-defense candidates. VFW-PAC also tracks which elected officials support our VFW Legislative & Security Priority Goals.

The Federal Election Commission (FEC) regulates all VFW-PAC operations. This includes providing the FEC with scheduled reports of all VFW-PAC activities.

Who can donate to VFW-PAC? Donations and solicitations can only be accepted from VFW and Ladies Auxiliary members and employees. VFW Departments, Districts, County Councils, Posts and Auxiliaries may contribute to VFW-PAC through fundraising events. Fundraising events must have signs or flyers posted that this is a VFW-PAC fundraiser. All monies collected from fundraising events should be sent within 30 days of the event.

3. Award to the Department with the most involvement by Auxiliaries in response to any National Legislative Action Alert.

4. Award to the Department with the best overall promotion encouraging members to communicate with legislators on veterans' issues in detail.
5. Award to the Department with the best educational program on the legislative process in detail.
6. Award to the Department with the best overall promotion of VFW-PAC in detail.
7. Outstanding Performance Award in each Membership Group based on criteria on Page 1.
